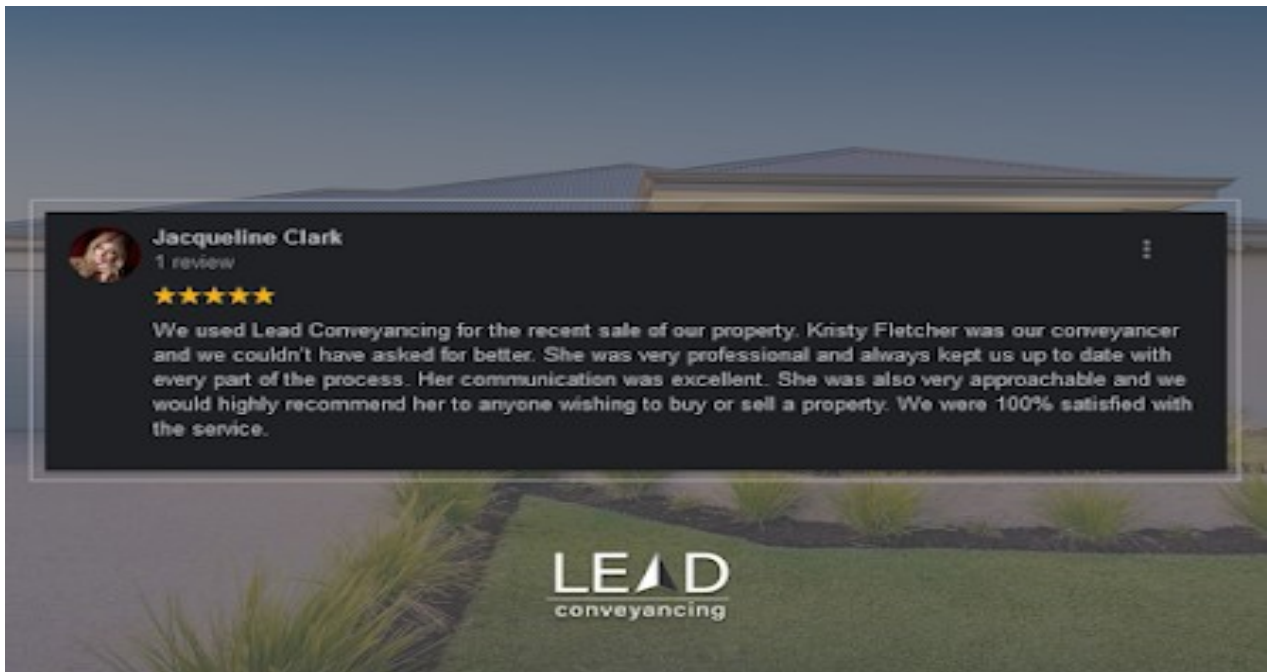




## Sydney Conveyancing Company Wants to Serve More First Time Property Purchasers
